मंदिरों, धर्मशालाओं को बनने दिया? मान लिया जाए कि सरकारी विभाग अपनी जिम्मेदारी निभाना भी चाहते थे तो क्या वे ऐसा कर सकते थे? धर्म के नाम पर मंदिर-मस्जिद कहीं भी बन जाता है और सरकारी अधिकारियों की हिम्मत नहीं होती कि वे उसे रोक सकें क्यों कि यह मामला आस्था का है? आस्था के नाम पर बहुत सारे खून माफ हैं। रातों-रात मंदिर बन जाते हैं और मूर्ति स्थापित हो जाती है तो क्या किसी की हिम्मत होती है कि कोई उसे हटा दें? मान लिया जाए कि राजनैतिज्ञ व सरकारी विभाग नालायक होते हैं तो क्या अभी तक किसी टीवी चैनल ने ऐसे मंदिरों, मस्जिदों के निर्माण पर कोई सनसनीखेज खबर दिखाया? हजारों करोड़ रूपए मंदिरों पर चढ़ावा आता है तो क्या इन्होंने प्रस्ताव रखा कि केदारनाथ, बद्रीनाथ आदि का निर्माण उसी पैसे से करेंगें? क्या मीडिया ने इस प्रश्न को देश के सामने रखा?

घुमाने से सब ठीक हो जाएगा। यह बात जरूर है ज्यादातर राजनीतिज्ञ व अधिकारी भ्रष्ट हैं लेकिन जनता को अपनी भी जिम्मेदारी निभानी चाहिए।

वहां की प्रकृति को खतरा विज्ञान से है तो ऐसे में धर्माचार्य सरकार को निमंत्रण दें कि हजारों करोड़ रूपए मंदिर के चढ़ावे से स्वयं इन क्षेत्रों का विकास करेंगे। तमाम और विषयों पर मीडिया शुरू से लेकर अंत तक ब्योरावार बात को रखती है कि क्या होना चाहिए और क्या नहीं होना चाहिए। क्या ऐसे मामलों में भी कभी वह कर पाती है? ऐसा इसलिए कहना पड़ रहा है कि हर 5-10 मिनट पर खबरिया चैनल सरकार को गलत बता रहे हैं और यह भी कहना नहीं भूलते कि क्या किया जाए या क्या नहीं। विभिन्न दलों के नेताओं ने क्या किया, क्या कहा वह मुख्य खबर होती है। यदि कोई मामूली सी विवादित बात हो तो जो जान-माल की क्षति है उसे भी भूल जाते हैं। केदारनाथ, बद्रीनाथ और जोशीमठ आदि पर जो कहर बरपा, वह निश्चित तौर से बेहद दुःखद है। लेकिन पुजारियों एवं श्रद्धालुओं की भी कुछ जिम्मेदारी बनती है, क्या वे निभाते हैं? सरकार वह कौन सी जादू है कि जिसकी छड़ी

BJP, CPM, JD(U),LJP, CPI, etc leaders not only met Dalit/Backward teachers, students and intellectuals but openly opposed the introduction of the fouryear under-graduate programme. BJP Leader Arun Jaitley, in a letter to the HRD Minister, has demanded to put an embargo on this course. JD(U) leader Sharad Pawar has also done the same thing. CPI(M) leader Sita Ram Yechury has met the Prime Minister in this regard. A job which was supposed to have been done by Bahujan Samaj Party has been done by others. This is going to cause maximum damage to Dalits and Backwards. BSP has got about 40 MPs and if each one of them is given the freedom to act accordingly, then the atrocities on Dalits will reduce considerably and Dalits /Backwards will march forward speedily, their rights will be protected and wherever their share is lacking in different sectors, it could be bridged.

At present, condition of Dalit community is such that neither they are patronized by their own parties nor by other national parties who have a grudge that they do not get Dalit votes and as such they should not work as in the past. Sometimes these parties even go to the extent of telling Dalits that they should go to BSP for resolving their grievances. Unfortunately BSP doors are found closed and MPs, MLAs and leaders do not have the guts to raise issues of the Dalit/Backward community. In these circumstances, where should these people go? I know BSP leaders will not be happy with my comments but it is a fact and the people who are feeling hurt by my statement should go and talk to the BSP Supremo and they will be able to know the reality. I know it fully well that not a single BSP leader or worker has the courage to go to Ms Mayawati and speak to her as suggested

# Constitution of National SC/ST/OBC Students & Youth Front (NSOSYF)

One lakh students will be brought under the banner of this Front.

Some students and youths, belonging to Brahmin, Rajput and Vaishya castes, who constitute only 15% of the society, raised a big hue and cry in Delhi against corruption and rape. How is it that Dalits, Backwards, Minorities and others belonging to progressive groups cannot launch a struggle for their rights and self-respect. Different groups of students and youths from these communities are individually holding demonstrations for their rights but their impact is not visible on the surface nor is likely to be so. Main reason for this situation is that these groups have not got a national level leader. Under the leadership of Dr. Udit Raj, All India Confederation of SC/ST Organizations has been in existence for the last 15 years in a strong way. This is the only organization which has been raising burning issues and has been working like a permanent political party. If SC/ST/OBC students decide to associate themselves with the Confederation, then this premier organization will not only guide and educate them but will always stand by them in all their struggles. Struggle for reservation in private sector has been launched by the Confederation . beneficiaries of this struggle will be students and youths and not the office bearers of the Confederation. because of the struggle of Confederation that three constitutional amendments will be adopted and reservation was saved as a result of which lakhs of SC/ST students and youths have reaped the fruits of reservation. If the students and youths launch their campaigns at School, College and University levels for their amenities and rights, can it be helpful in achieving goals of their lives? Will they be able to fulfil the dreams of their parents? Government jobs are shrinking fast and it is only through reservation in private sector that SC/ST students and youths who are in majority will be able to get jobs. At present, there is maximum scope of jobs in the private sector. Dreams of students and youths will be realized with the constitution of National SC/ST/OBC Students & Youth Front (NSOSYF). In the year 2013-14, one lakh students and

youths will be brought under the banner of this Front.

So far SC/ST students and youths have not got proper leadership and direction. Their approach is restricted to school and college problems like admission, hostel accommodation and scholarship. They cannot get even these demands fulfilled because they are not affiliated with any national level organization. Despite all these problems, students and youths can achieve their main goal of getting jobs. Even though they take less part in the and youths, joining any walk of life, after coming out from schools and colleges will get a ready-made platform in the form of NSOSYF just as NSUI is to Congress. There are many students and youths from colleges and universities who have got brilliant ideas and energy but there is no parent organization under whose banner they can work and it is through the medium of the Confederation that a proper direction can be given to the society. If SC/ST students face any problems in any

activities at school, college and university level, but their main goal should be to affiliate themselves wholeheartedly with National SC/ST/OBC Students and Youth Front. Why the SC/ST/OBC students and youths cannot organize a much larger front as compared to the front organized by Anna Hazare and Kejriwal? Some youths and students are under the wrong impression that by launching a struggle by remaining in their own organizations, they can achiev big goals which is only a halftruth. Whether it is in the field of knowledge or any struggle, an organization can achieve its goal only if it is of the level of organizations like SFI, AISF, ABVP, ASUI etc. NSOSYF is being conceived on the lines of NSUI, student front of the Congress Party and BJP's ABVP. We can call our organization a parent organization also. Students

University, they can take advantage of the strength of NSOSYF and resolve their problems expeditiously. Students and youths can shed their intellectual inhibitions and use their knowledge and experience for the welfare of the society which will ultimately throw up political leaders from amongst them. In the present context, most of the SC/ST/OBC leaders believe in doing lip service because like the upper caste people, they do not have any national level organization where they could get acquire social and political knowledge and experience. It is no exaggeration to say that the most important task is to organize the younger generation which NSOSYf has undertaken upon itself to do.

For all types of competitions, some pople have set up coaching institutes and presume that by imparting knowledge, welfare of students and youths can be achieved but this again is a half-truth. The number of Dalits, Adivasis and OBC educated people and youths has increased but the number of Government jobs has not increased in that proportion. In fact, the number of Government jobs has shrunk. Under these circumstances, despite the competitive skills achieved by Dalits, Adivasis and OBC educated people, only 4 to 5% of them could become IAS, IPS, Doctors, Engineers, Clerks, Stenos, Constables, Armymen etc. and the rest will remain unemployed. At the national level, there is no organization to represent the interests of the communities which could propagate the ideals of Phule, Shahu and Dr. Ambedkar and there should be an organization which should prepare those SC/ST and OBC students, who are not able to qualify for the Government jobs for other fields including social and political leadership. There is now greater scope of jobs in the private sector and without reservation in the private sector, all the education and skills acquired by SC/ST/OBC people will become useless. People of these communities hardly take to trade and industry and the Confederation has now come to the view that even though a lot of development has already taken place in social and political fields and is further taking place, but now the time has come when steps should be taken to make progress in the economic field. NSOSYF will make significant contribution in this area so that the people of these

communities who are not successful in Govt jobs, social and political fields, can enter the world of trade and industry and realize their

d r e a m s . In our history after Independence, no student wing of any political party has launched any struggle to resolve the problems of SC/ST/OBC students and youths. It is well known that most of the students of the political parties have been under the control of Manuvadis and even if it is so, why should they fight for our The upper caste causes. people have shown discrimination towards us for centuries and which is continuing even now and under these circumstances, it is imperative for us to make our own organization which has not been done till date. Some upper caste students are also Ambedkarites and progressive in their outlook and for them our doors shall always remain open.

Whosoever helps the onelakh strong SC/ST/OBC students and youths Front called NSOSYF will be doing great service to these communities which we owe to them and must repay. Whosoever gets this information, should pass it to maximum number of SC/ST/OBC students and youths and persuade them to become members of NSOSYF. Everybody's contribution who has helped in raising a strong force of 1 lakh persons will be duly recognized.

# **Confederation State Unit** Dissolved, Reinvigoration Soon

Srinagar : 16.06.2013: Shri R K Kalsotra, State President, J & K unit of All India Confederation of SC/ST/OBC Organizations addressed the media persons in Srinagar in which he apprised them of the issues of SC/ST/OBC's in the state. He stated that the J & K unit of All India Confederation of SC/ST/OBC Organizations, has been fighting for the protection and implementation of the Constitutional rights of the weaker sections in the state. It has, many achievements to its credit among which a few are : getting one step up reservation, promulgation of SRO 110, representation of SC/ST members in PSC/SSRB, enactment of Reservation Act, 2004, restoration of 8 percent reservation for SCs and enhancement of reservation in promotion for STs from 5 to 10 percent, implementation of profession based to caste based reservation for OBC's, inter district reservation for SCs, lowering of marks criteria for scholarship from 60 percent to 55 percent, and other government orders passed/rectified so that SC/ST/OBCs of the state are properly represented in public employment. The state unit has worked relentlessly, in conjunction with the national body at Delhi, over the past fifteen years to achieve goals set by the confederation at the state and national level. The legislators / ministers belonging to SC/ST/OBC communities cutting across party lines, various social & religious organisations, people from different sections of society, especially the cadre of confederation have supported its agenda but a lot more needs to be done for accomplishment of remaining goals and to meet Those to be achieved are:

-Reservation in recruitment in all forms including regular appointments: Rehbar-e-Taleem, Rehbar-e-Zerat, Rehbar-e-Sehat, Consolidated, contractual, Adhoc, Temporary, need basis appointments in Govt. Corporations, J&K Bank, J&K Grameen Bank, Cooperative Banks, NRHM, SPO's, Anganwari workers and other departments, as they are subsequently regularized. To calculate pending backlog of over 60,000 posts in these departments and launch special recruitment drives for SC/ST/OBCs to fill up these posts.

-Reservation should be provided in private sector

-Recruitment without consulting SSRB and PSC should not be carried out. Stop adhoc recruitment and provide reservation to the fullest extent in direct recruitment.

-Maintenance of roster and roster based seniority and promotion thereon in the government departments and PSU's, clearance of backlog vacancies in promotions, SRO 110 of 2000 which nullified the Catch up rule, must be implemented in letter and spirit as also the 85th amendment Act of the Constitution of India. Maintenance of roster point seniority for senior level posts of KAS, Engineering, Education, and other equivalent posts as also to scrap SRO 481 of 2010 as it denies a fair chance to SC/ST/OBC candidates to be promoted as Sr. Lecturers.

-Provide reservation: in the Districts according to proportion of population of SC/ST's at District level for district cadre posts, however, till this is done, give 1st and 2nd chance to local SC/ST and 3rd chance to Inter District category candidate. emerging challenges. Also 1st provisio to Section 3

of the Reservation Act, 2004, which seals total reservation to 50 percent, be deleted.

-In judiciary: reservation to SC/ST/OBCs for elevation to the High Court.

-Central budgetary allocation: for SC's and ST's for the year 2013-14 is Rs. 45000 crore and Rs. 21,000 crore respectively, consequently, the Confederation impresses upon the state to demand Rs. 2000 crore for SC's and Rs. 1000 crore for STs as its share for the state immediately so that it could be utilized from April 2013 itself for generating job avenues for these communities so that inclination of unemployed youth towards public employment is lessened. On similar lines, the state should provide 10 % (Rs.3800 crore) and 8% (Rs.3500 crore) share for ST's and SC's respectively from out of total state budgetary allocation for the year 2013-14. # Demonstration held at Jantar-Mantar against FYUP

The Joint Action Front for Democratic Education (SC/ST/OBC/Left) (JAFDE) held a demonstration on 22nd June, 2013 at Jantar Mantar to demand from the Govt. to stop the implementation of four year undergraduate programme (FYUP) that is going to be introduced in Delhi University. how a vice chancellor can change it from 10+2+3 to 10+2+3? It is surprising the Congress led Government is not honoring the policy ushered in by its own leader, the late Shri Rajiv Gandhi. The argument offered by the Vice-Chancellor that it is a matter of University autonomy is totally baseless and fraudulent. Rather the VC has encroached on the authority of the Parliament.

Dr Udit Raj, convener of JAFDE, said that we are compelled to go for nationwide agitation as the Govt. is not heeding our demands. Today's

demonstration has proved that not only students and teachers are part of this movement but outside society like dalits, backwards and social & political workers are equally agitated against the FYUP. He expressed that given the opportunity about the various programmes and policies to uplift the people, the most important would be education. Education is the key to take forward the country ahead. We fail to understand how the Government is being misled by one Vice-Chancellor and ignoring the voices of people from all walks of life and

specifically SC, ST, and OBC. Most of the political parties like BJP, LJP, JD(U), CPI(M), and CPI have taken a stand against FYUP for these reasons: how the holders of three years degree from other universities will get admission in DU and how the holders of four-year degree from DU will pursue further studies in other Indian universities; how will a four-year DU degree match with the three-year undergraduate degree in other Indian universities; the course contents of other universities will be different and how that will be reconciled; will it not

create discrimination in getting the jobs; will it not be difficult for rural and Indian languages background students to study compulsorily Maths, Science and English; will it not encourage inequality in the same degree with the multiple exit points, i.e., diploma at two years, bachelor at three and honors degree after four years. The idea of parity in higher education will be completely destroyed. Remember DU exists within the ambit of other central universities. Change can't be brought in this arbitrary, hasty, authoritarian manner.
